### New Refrigeration for Mount Boucherie

Fraser Valley Refrigeration Ltd. has been awarded the contract for the replacement of the Mount Boucherie Arena refrigeration system and dehumidification equipment for a total of \$422,236. R.H. Strong and Associates Inc. reviewed the four bids received to replace the equipment. The Mount Boucherie Master Plan had identified the immediate need to replace the aging mechanical equipment in order to continue smooth operation of the facility.
