Action Plan for the Year 2000 for the Economic Development Commission. Almost There!

In 1999 Central Okanagan residents reduced, reused, and recycled their way to reducing waste going to local landfills by 47% since tracking began in 1991. While garbage buried in local landfills increased slightly by 1610 metric tonnes over last year, the population also increased by 2,887 during the same time. Increases were noted in the volumes of materials from the construction and demolition sectors as well as a slight increase in the amount of garbage generated per household. In the year 2000 the new Curbside Blue Bag Recycling Program will get underway, aimed at increasing the amount of recycling by 20 - 40% per household. In addition, waste reduction initiatives will continue to focus on commercial and industrial sectors to assist them with their waste reduction efforts.
